

**RELEASE OF LIABILITY, WAIVER OF CLAIMS,
ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT**

BY SIGNING THIS DOCUMENT YOU WILL WAIVE, GIVE UP OR LIMIT CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE OR CLAIM COMPENSATION IN RESPECT OF DAMAGES OR INJURIES ARISING OUT OF AN ACCIDENT OR NEGLIGENCE IN CONNECTION WITH ANY USE OF OR PRESENCE AT THE EDGE GROUP INC. AND ASSOCIATED COMPANIES (hereafter “THE EDGE”) FACILITY OR EQUIPMENT

I hereby acknowledge that I am not under any prohibition from handling, possessing or using firearms or ammunition or prohibited devices of any nature.

I also affirm that I am not under the influence of any drugs or alcohol that may impair my judgement or physical capacity.
(In other words, ask yourself: Would the POLICE be upset if you were here.)

Information collected on this form shall be treated as confidential and will only be stored as required by law, but may be released at THE EDGE’s sole discretion to police or other authorities.

Important: This document will affect the legal rights and liabilities of yourself, your heirs, executors, administrators and next of kin. Please read carefully before signing because you are agreeing to waive any claims against THE EDGE.

I ACKNOWLEDGE THAT A COPY OF THIS DOCUMENT WILL BE MADE AVAILABLE TO ME IF I REQUEST.

I, (print name - adult only) _____ (“USER” or “I”) irrevocably agree to, and acknowledge having read and understood the terms and conditions set out here, as a condition to my presence upon, use of, or involvement with any THE EDGE Facility and Equipment (as those terms are defined below) at any time or for any reason, whether it is at my request or for my own purposes, as an invitee of THE EDGE, or as part of a function or activity sponsored, sanctioned or supported by THE EDGE.

“Facility” or “Facilities” mean any premises owned or operated by THE EDGE including without limitation:

1. The premises and facilities located at Bay 4, 510 – 77th Ave S.E. Calgary, Alberta;
2. The premises and facilities located at 14 Stalwart Industrial Dr, Gormley, Ontario;
3. Any location, premises or facilities where any activity or function sponsored or held by THE EDGE is located; and
4. Any parking facilities located in front of, in the vicinity of or around such locations, premises or facilities.

A. SPECIFICALLY, WITHOUT LIMIT, I ACKNOWLEDGE & AGREE THAT:

1. The Facilities include shooting ranges where firearms may be legally discharged and may be discharged at any time; **Firearms, ammunition and other paraphernalia related to firearms may be present on the Facilities;**
2. The use and the discharge of firearms, ammunition and other paraphernalia related to firearms is subject to certain inherent risks and hazards (including without limitation, exposure to lead particles and other potentially harmful contaminants) and that the use of firearms and the activities associated with them is and are potentially dangerous;
3. In entering upon or using the Facilities I do so at my sole and absolute risk, notwithstanding that I may or may not be familiar with any or all aspects of firearms, ammunition and other related paraphernalia, the discharge of firearms or the risks and hazards associated with them;
4. While on or using the Facilities I am absolutely and solely responsible for my own conduct, safety and well-being as well as the conduct, safety and well-being of any guest accompanying me (including without limitation any minor);

5. I assume all risk for myself and anyone accompanying me for any injury (including death) or harm that I or they suffer, OR any injury (including death) or harm that I or they may cause to anyone or to the Facilities;

6. I will follow and comply with the directions, orders, range safety rules and facility etiquette policies as posted in and around the facility and as verbally expressed by the employees and volunteers of **THE EDGE** at **ALL TIMES**.

7. While at **THE EDGE Facilities**, I will employ proper safety practices, precautions, and act in a safe manner at all times, to protect myself and those around me and to minimize the risk of injury or harm to myself or to others;

8. Notwithstanding anything here to the contrary, **THE EDGE can** at any time deny me and anyone accompanying me, access to the Facilities or any parts of it, or request that I and those individuals accompanying me immediately leave the Facilities; and

9. **Any photography, audio or video recording in any form, made**, created or begun at the Facilities in whole or in part ("**Media**") **will be used only by me and will be for personal use only**. The Media will not be displayed, shown or in any way broadcast in any forum or media for commercial, artistic, creative, promotional, educational or informative purposes without the express written prior permission of a Director or Officer of **THE EDGE**.

I ASSIGN TO THE EDGE wholly and irrevocably all rights, including statutory or common law copyright, associated with any Media that is for any reason displayed, shown or in any way broadcast in any forum or media for commercial, artistic, creative, promotional, educational or informative purposes. **Notwithstanding the foregoing: under no circumstances is any Media to be used for any religious, commercial or political purpose** without the express written prior permission of a Director or Officer of **THE EDGE**.

B. WAIVER AND RELEASE

I, ON BEHALF OF MYSELF, my heirs, executors, assigns, representatives, or next of kin, **HEREBY WAIVE AND RELEASE THE EDGE** and its directors, officers, employees, volunteers, representatives, agents and assigns (the "Released Persons") **FROM ANY AND ALL CLAIMS**, demands, damages, costs and expenses (including legal expenses), actions and causes of action arising, whether directly or indirectly from or in consequence of any losses, injury (**including loss of life**), or damage to my person or to my property which I may suffer, sustain or incur in connection with or arising directly or indirectly in any way from my presence at, or use of, the Facilities or while attending or participating in any activity associated or connected with **THE EDGE**, including without limitation: all damages, costs and expenses arising from: (a) the provision of services of any kind; (b) the provision of firearms and ammunition, their loading or discharge; and (c) the provision of insurance or any lack of it.

C. I WILL INDEMNIFY, SAVE HARMLESS and be liable to the Released Persons in respect of:

1. Any and all costs, expenses, damages and other losses arising in any way out of the posting or broadcast of Media;
2. Any and all liabilities, claims, demands, actions, causes of action, judgments (including judgments for costs), costs or expenses (including legal costs, fees and disbursements related to defending any such claim, demand or action) which:
 - a. the Released Persons may suffer, sustain or incur as a direct or indirect result of any act or omission of any nature whatsoever of the USER or any guest or invitee of the USER; or
 - b. may be advanced by or on behalf of and or awarded to or for the benefit of the User as a result of or in any way arising from the User or any guest of the User gaining access to the Facilities.

I warrant and represent to THE EDGE that I have authority to sign this Release, Waiver and Indemnity Agreement on behalf of my heirs, executors, administrators, next of kin and myself.

If any part of this document is found to be unenforceable, that part shall be severed and the balance of this document shall remain in full force and effect. Without limiting the generality of the foregoing, if the Release on behalf of myself or my minor child is deemed unenforceable, the indemnities shall nevertheless remain in full force and effect.

The User agrees that any dispute related to this document, and to the User's or any minor child's attendance at the Facility shall be exclusively governed by the laws of the Province in which the used Facility is located, as well as applicable federal laws of Canada, and the User irrevocably attorns to the jurisdiction of the courts of the Province in which the used Facility is located.

I HAVE READ THIS RELEASE, WAIVER AND INDEMNITY AGREEMENT PRIOR TO SIGNING IT AND I UNDERSTAND IT.

This Release, Waiver and Indemnity Agreement shall remain in full force and effect in perpetuity for all attendances at **THE EDGE** throughout subsequent yearly renewals of membership, and despite the fact the User may not be or may cease to be a member of the Calibre Shooting Association or a user of **THE EDGE**.
